SELECTION CRITERIA FOR AWARDS 2017

Please note all *nominees* must be current financial members of the WA Occupational Therapy Association. If required please contact WAOTA to confirm eligibility

ELIZABETH ADAMS BEQUEST

- The nominee is a graduate of a WA School of Occupational Therapy and is recognised for meritorious service in Occupational Therapy
- The nominee has made a significant contribution to any field of Occupational Therapy

RECOGNITION OF SERVICE AWARD - GENERAL

- The nominee has provided consistent, outstanding service to WA Occupational Therapy Association (formerly OT AUSTRALIA WA) over many years
- The nominee has been a member of WA Occupational Therapy Association (formerly OT AUSTRALIA WA) for a minimum of 7 years

RECOGNITION OF SERVICE AWARD – RURAL

- The nominee has provided outstanding Occupational Therapy service to their rural community and has demonstrated commitment, advancement and promotion of Occupational Therapy in their rural community
- The nominee is currently working in a rural community

RECOGNITION OF SERVICE AWARD- STUDENT

- The nominee has provided consistent, outstanding service to the WA Occupational Therapy Association during their years as a student
- The nominee is usually the representative on the Association's Committee
- The nominee has been a member of the WA Occupational Therapy Association for a minimum of 2 years

YOUNG THERAPIST AWARD

CLINICAL EXCELLENCE IN MENTAL HEALTH AWARD

- The nominee has demonstrated clinical excellence in the field of mental health, the focus being on professional dedication to direct clinical practice and contribution to mental health occupational therapy, regardless of years of experience
- The nominee has shown commitment to best practice, consumer focus and involvement, and has demonstrated innovation within a service or when undertaking projects

CLINICAL EXCELLENCE IN PAEDIATRICS AWARD

- The nominee has demonstrated clinical excellence in the field of paediatrics, the focus being on professional dedication to direct clinical practice and contribution to paediatric occupational therapy, regardless of years of experience
- The nominee has shown commitment to best practice, consumer focus and involvement, and has demonstrated innovation within a service or when undertaking projects
